Our open mezzanine lounge caters for medium to large groups looking for a more intimate evening. Old chesterfield couches & cushioned lounge chairs accommodate a private bar & fully facilitated space.

Nestled at the rear of the mezzanine is a private room with full surround booth seating, this upper floor area works to cater for any style of function or event.

The Restaurant

Straight through the main doors of the ground floor is our restaurant. Bosting a combination of lounge and dining in a casual warm & welcoming environment the restaurant is our main hub open till the early hours of the morning every day.

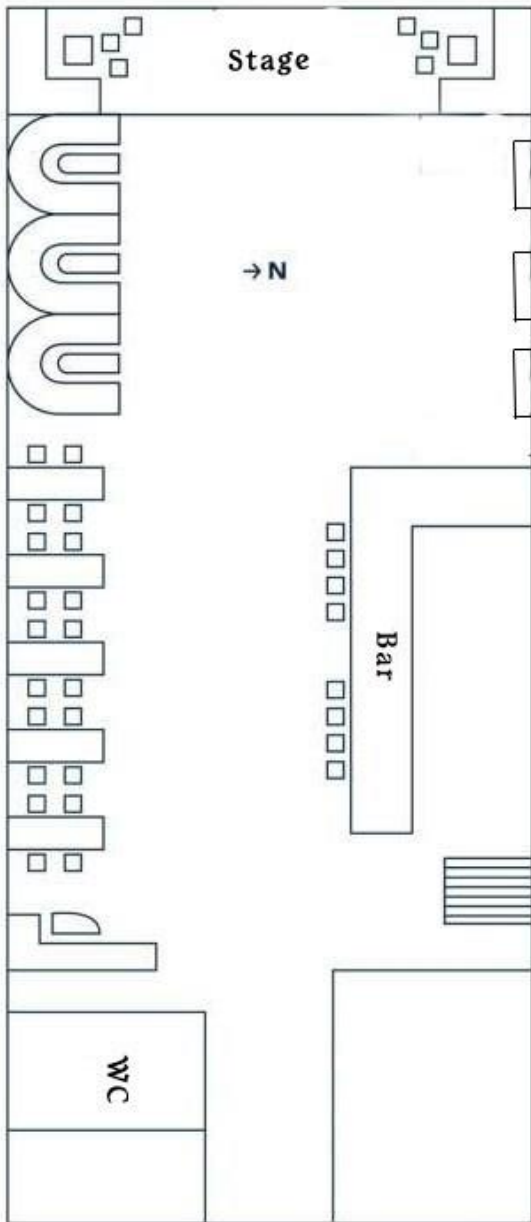

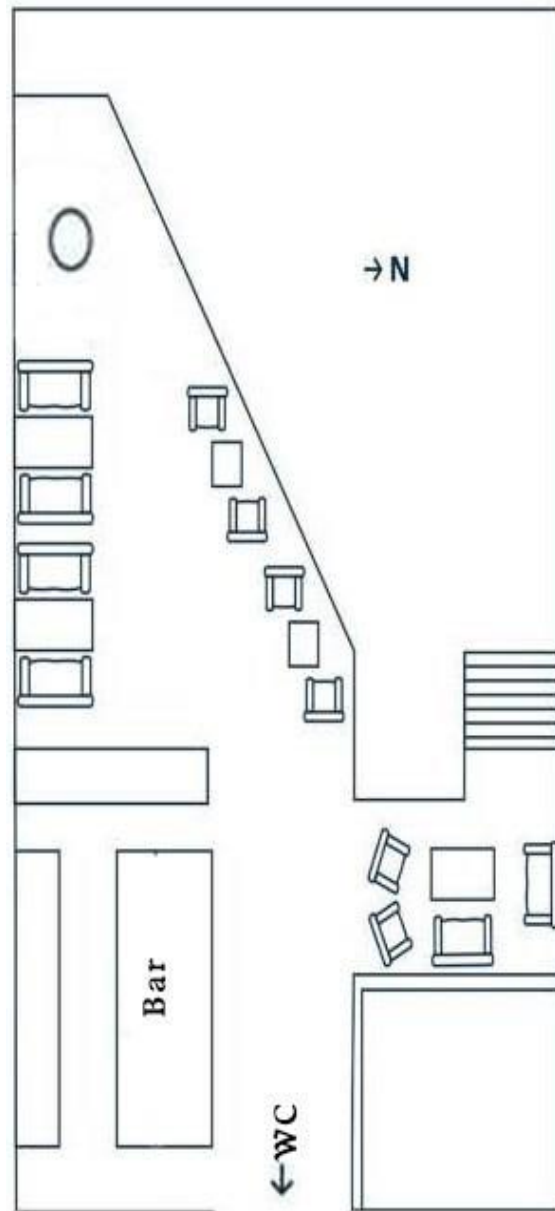


Floor Plan

Terms and Conditions

TENTATIVE BOOKINGS & CONFIRMATION

Tentative bookings may be held for a period of up to 48 hours only. At which time the booking will be released if a signed copy of the terms and conditions along with deposit has not been received. Reservations will only be confirmed on receipt of signed copy of the terms and conditions and deposit.

DEPOSIT

There is a standard \$500 deposit required to confirm the booking, unless otherwise specified by The Noble Experiment. All deposits are redeemable within The Noble Experiment only.

PER HEAD SPENDS

In lieu of minimum spends all bookings will require a per head cost to cover catering and staffing of the event. Per head costs are chosen by the host prior to the event and applied on the confirmation of final number of expected guests. Where final numbers are not confirmed prior to the event a credit card or credit details will be taken to secure payment at the agreed amount of attendance on the night.

CONFIRMATION OF ATTENDANCE

Anticipated final numbers are required seven days prior to your event. Payment will be based on final catering numbers provided seven working days prior to your event or attendee numbers on the day, whichever is greater.

CATERING REQUIREMENTS

All guests attending the function must be catered for by selecting one of The Noble Experiment's catering packages. Menu and beverage selections are required seven days prior to your event. Should selections not be advised at this point your menu selection cannot be guaranteed. Special dietary requirements must be communicated to The Noble Experiment seven days prior to the event.

BYO POLICY

No food or beverage of any kind will be permitted to be brought into The Noble Experiment for the consumption of guests without prior consent from The Noble Experiment. The exception being the external catering package and use of celebration cakes/cupcakes. A service fee of \$2.50 will be charged per head for cutting, plating and serving of affirmation cakes.

RESPONSIBLE SERVICE OF ALCOHOL

The Noble Experiment adheres to the responsible service of alcohol legislation. All staff are trained in the Liquor licensing accredited 'RSA - Responsible Service of Alcohol' and by way of law may refuse to serve alcohol to any person who they may believe to be intoxicated. Any intoxicated person will be removed from the venue. In accordance with liquor licensing laws of Victoria, minors (under 18) are only permitted on premises in the direct company of their parent or legal guardian and must not consume alcohol.

AV FACILITIES AND ENTERTAINMENT

It is the organiser's responsibility to ensure that any external AV equipment or devices such as iPod's DVD's are compatible with The Noble experiment's in house equipment. You may test any of this equipment at a mutually convenient time prior to the function. Approval by management at The Noble Experiment is required should the organiser wish to hire a band, DJ or any other form of entertainment. Noise restrictions may apply.

SET UP AND DELIVERY

External audio visual and production companies are required to make contact with The Noble Experiment event staff seven days prior to the event. The client should ensure event staff are advised of all goods/ packages to be delivered and that they are adequately marked with the contact name, date of event and contact number. All equipment must be removed at the conclusion of the event unless previously arranged with The Noble Experiment event staff. Confetti, rose petals, table confetti, are not permitted unless approved by management at The Noble Experiment.



Terms and Conditions

DAMAGES AND CLEANING

Organisers are financially responsible for any damage to the building, furniture or property during and immediately following the function, including any costs for repair or replacement at current market price. The organisers of the function are responsible for damage caused by their guests, outside contractors or agents prior to, during and after the event.

CANCELLATIONS

Cancellations more than 14 days prior to the function will receive a full refund of deposit. Cancellations within 14 days of the function will forfeit the deposit.

CLIENT RESPONSIBILITY

The Noble Experiment will not be held responsible for the loss of or damage to property left on premise prior to,

during or after an event. The client is required to inform all relevant persons involved in the organisation of the event, including colleagues or contractors of The Noble Experiment's terms and conditions outlined here in.

PRICE VARIATIONS

Every endeavour is made to maintain our prices as originally quoted to you however, they are subject to change. Should any increases occur, we will notify you immediately.

PAYMENT

Payment must be finalised by cash or credit card on the day, at the conclusion of the event or prior to the event taking place. At the start of your event, a credit card is required to be held behind the bar until payment has been received at the conclusion of the function. All prices are inclusive of GST.
