- Scheduled, first time face to face meeting and submission of NOIM

- PA system provided on the day and for rehearsal

NB: Our first consultation can take between 45 to 90 minutes and generally takes place in my home office, though I am flexible and would be able to meet you at a mutually desirable location. Please contact me soon to book an appointment time so we can get that ball rolling.

### Payment Agreement

Upon booking me, a non-refundable 20% booking fee is required to lock in your date. You can pay this deposit with cash at our first hello, or online bank transfer the day of/after.

The balance of your payment is requested to be paid no later than 10 days before your wedding date.

### Cancellation Terms

On the odd occasion, this sometimes happens. The agreement for complete cancellation of your ceremony is:

- 4 weeks prior to ceremony, any money paid after the non-refundable deposit will be refunded to you.
- 2 weeks prior to ceremony, 50% of money paid after the non-refundable deposit will be refunded to you.

- 10 days or less prior to ceremony, no refunds for cancellation.
- Any ceremony that requires rescheduling, a date transfer fee will apply (\$80)

*\*\*Please note that timelines differ based on ceremony type.*

## Legal stuff

To legally marry in Australia, you must follow these steps...

Are you able to be legally married?

Generally to marry in Australia you must be over the age of 18 and not be already legally married. If you are married now we can still plan your ceremony but you must have received confirmation that you are no longer married before the ceremony date and I must sight your divorce certificate.

The first step – the NOIM

In accordance with the Marriage Act 1961 the Notice of Intended Marriage form must be completed no later than one month prior to the ceremony and no more than 18 months before.

After our initial consultation and your booking confirmation we will complete the NOIM.

*To help complete the NOIM you need to show me*

- a passport or...
  - an official birth certificate, or an official extract of an entry in an official register, showing the date and place of birth of each party
- If you don't already have one, you can apply for one at your state's Births, Deaths and Marriages office or the court house. This is at your own cost and responsibility.

### Proof of identification

The Marriage Act states that your marriage celebrant should not solemnise a marriage until he or she is satisfied that both parties are who they claim to be.

I will need to certify your identity, in which case the following proofs of identification will suffice.

- a driver's licence
- a Proof of Age/Photo Card
- a passport
- an Australian citizenship certificate along with another form of photographic evidence.
