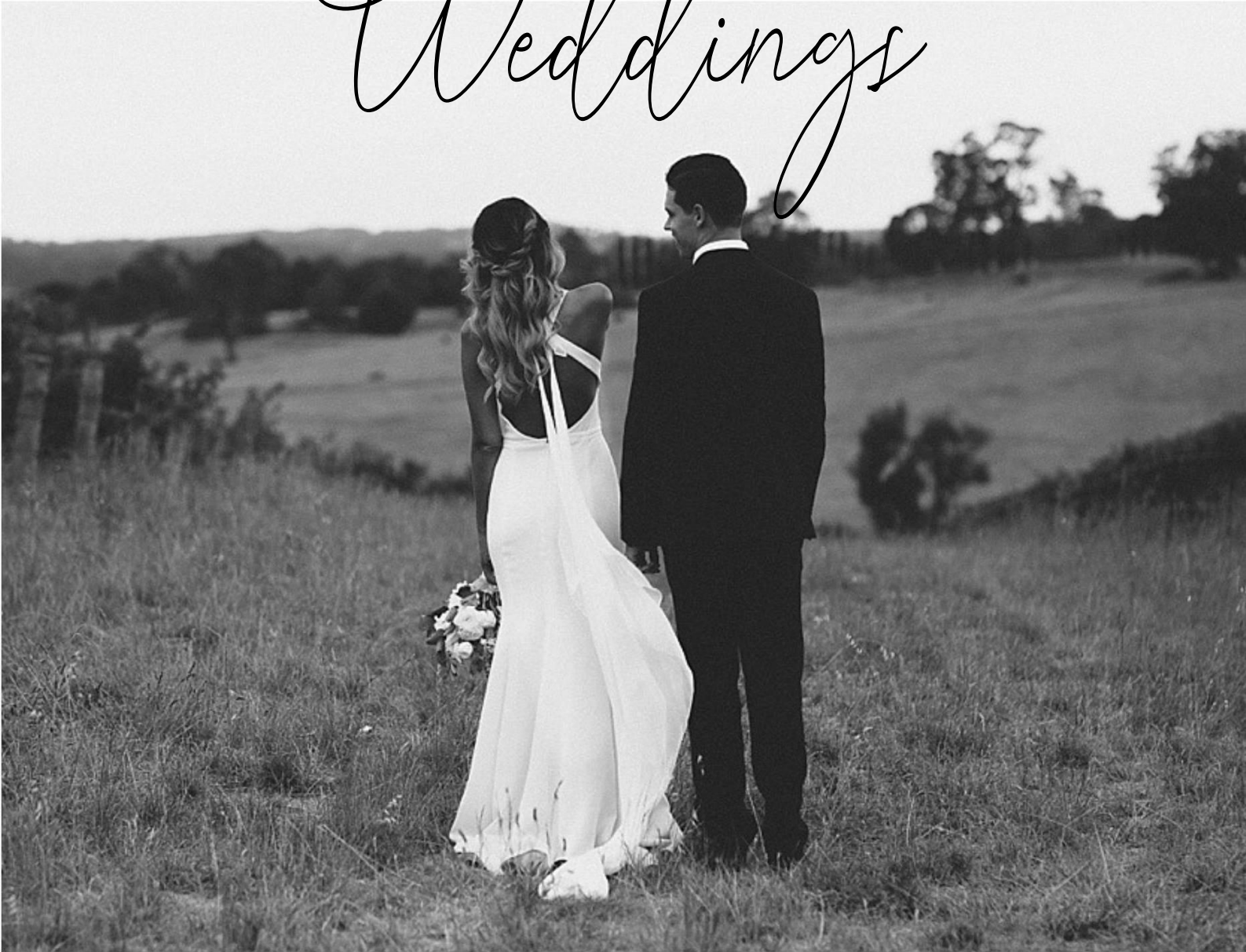

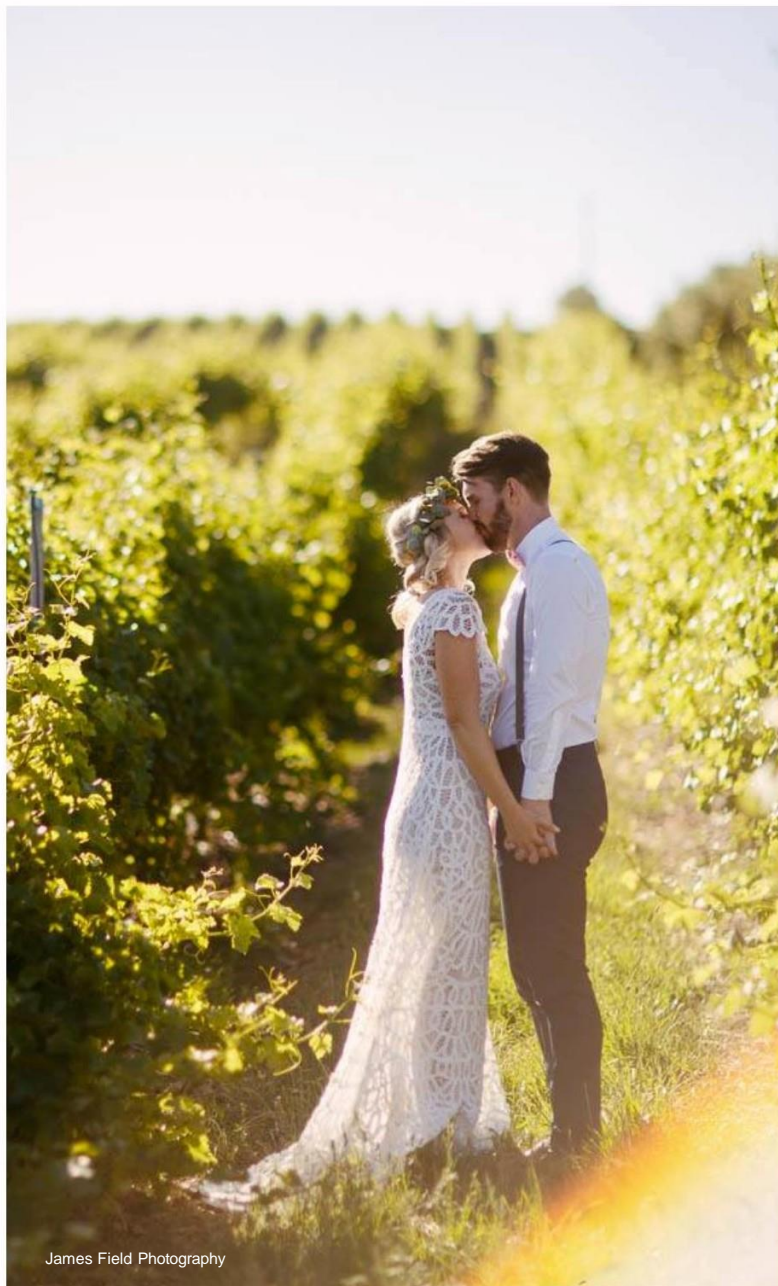
We like to keep it simple here at the Block, with casual, laid back affairs in our stunning original Hayshed and expansive Gardens.

We have teamed up with Venue Productions, South Australia's best wedding stylist as voted by the brides and grooms of the Australian Bridal Industry Academy to provide you with a vast range of lighting and draping options for your ceremony and reception. Think hundreds of festoon globes scattered across our Hayshed roof, beautiful twinkling fairy lights lining the trees on our lawns, or luxurious drapes surrounding the original, hundred year old wooden pillars.

Ask your wedding coordinator for the available options, ranging from \$500 to \$3000.



the fine print

A minimum guest number of 60 applies, however, if you have less, please talk to us!

A maximum guest number of 150 applies.

Prices subject to change at any time at the discretion of Barristers Block.

Beer and Cider varieties are subject to change at the discretion of Barristers Block.

Wine selections are subject to change at the discretion of Barristers Block.

All inclusive price includes use of existing pallet furniture, various wine barrels, black tolix chairs, up to 30 white americana chairs for the ceremony, gift table, cake barrel, cake knife and glassware.

All inclusive package does not include table linen, table service for drinks or tray service for all food (tapas items only).

Cellar Door remains open until 5.00pm, however early closure from 4.00pm is available for \$2500.



Booking & Payment Schedule A deposit of \$2500 is payable within seven days of the date of the Quote. Barristers Block reserves the right to cancel a tentative booking where no deposit has been received. Deposits are non refundable. A \$500 security bond is required to cover any Damages. This bond is refundable upon inspection of the property after your Function. Payment in full for food, beverages, venue hire and any additional agreed extras is required thirty days prior to the event. Any additional expenses incurred during the Function require payment within seven days of the event. Barristers Block reserves the right to hold credit card details for this payment. Payment is accepted via business cheque, credit card, cash or direct deposit. A surcharge of 1.8% applies for credit card payments. Personal cheques will only be accepted by prior arrangement. A late payment by the hirer attracts interest at 15% per annum.

Cancellation In the event that a Function is cancelled the following conditions shall apply: Deposits are non refundable. If your Function is cancelled within 60 days of the event day, the Hirer shall pay a fee of up to 50% of the estimated cost of the Function. If your Function is cancelled with 20 working days of the event day, the Hirer shall pay a fee of up to 100% of the estimated cost of the Function. All cancellations are to be provided in writing, addressed to the Wedding & Event Manager.

Final Attendance Final confirmation of guest numbers is required 28 days prior to the event day. You will be charged based on this number. Any reduction in this number after 14 days will not be refunded or credited. Should you need to increase your guest numbers after this date, we will endeavour to accommodate this request but cannot guarantee availability. You will be charged for any increase to the numbers accordingly.

Use of Venue & Finish Time The venue is available exclusively to the Hirer from 5.00pm for both the ceremony and reception. The Barristers Block Cellar Door operates until 5.00pm every day. Access to the venue from 4.00pm is available for \$2500 on weekends, or \$1500 on weekdays. All food and beverage service will cease 30 minutes prior to the agreed finish time of the Function. As per our liquor licence, you are required to vacate the premises by 11.45pm.

Damages You will be financially responsible for any damages, theft or breakages caused to the property and/or equipment of Barristers Block. You will therefore bear the cost of repairs/replacement as determined by Barristers Block. The cost will be taken from your security bond.

Security For Functions over 100 guests, security will be required as an additional cost. One guard is required between 100-130 guests, and two guards are required over 130 guests. This will be charged to you at \$80 per hour for the duration of your drinks package. The presence of security is not negotiable.

Music & Entertainment Barristers Block requires notification of all forms of entertainment. As per the Musicians Award, all entertainers must be provided with a meal. You will be required to pay for any food or drinks consumed by the musicians, entertainers, photographers and videographers. As this is a residential area we are required to take into consideration our neighbours and you may be asked to reduce the volume level of the entertainment. It is a condition of our licence that all evening entertainment concludes at 11.30pm.

Hirer's Property Barristers Block is not responsible for any goods left on our premises. All items must be collected by 9.00am the day after your event.

Cleaning General cleaning is included in the cost of the Function. Additional cleaning charges may be incurred where a Function caused additional cleaning considered to be over and above the normal.

Confetti & Candles We do not permit the use of confetti on the premises, however, flower petals are permitted. Should confetti be used against our will, you will be required to cover the cost of removal. We do not permit the use of candles without approval from the Wedding & Event Manager. Candles or any type of flame are not to be used on total fire ban days.

Fire Evacuation In the unlikely event that the venue is required to be evacuated from natural disaster such as fire or flood, we are required by law to shut down the premises including your Function. We will do our best to accommodate your Function at another location, failing this, the day following your event will be available to reschedule.

Responsible Service of Alcohol Barristers Block reserves the right (under the Liquor Licensing Act, 1997 - Section 108 and Section 125) to refuse serve of alcohol to intoxicated or disorderly patrons. These patrons may also be asked to leave the premises. You will be charged per guest as per the agreed food and beverage package irrespective of the actual consumption of each guest. Barristers Block will not serve persons under 18 years of age. If licensing determines security staff are required, the cost of this is to be borne by you as the Hirer. BYO alcohol is prohibited.

Compliance & Liability It is understood that you will conduct your function in an orderly manner in full compliance with the venue's management and with all applicable laws. The venue reserves the right to exclude or remove any and all objectionable persons from the Function or the premises without Liability. If the venue has reason to believe that a Function will affect the smooth running of the venue, its security or reputation, it reserves the right to cancel the event without Liability. Please ensure all displays, equipment, goods or materials do not obstruct the fire exists.

Basis of Agreement Our ability to provide the venue and all agreed catering, beverages, etc. is dependent upon and is subject to labour troubles, disputes, strikes or pickers, accidents, government (Federal, State, Local requirements), catastrophic fire days, restrictions upon travel, transportation, food, beverage or supplies equipment failure and other causes whether enumerated herein or not, which are beyond the control of the venue. In no event shall the venue be liable for the loss of profit or consequential damages suffered by the client, where based on breach of contract, warrant or otherwise. In no event shall the venue's liability be in excess of the estimate Function's cost.
