## TERMS + CONDITIONS

Seed Clare Valley endeavours to ensure your event runs smoothly and to provide you any information or service as requested within reason. The following terms and conditions are applicable to your event.

# 1. DEFINITIONS IN THESE TERMS AND CONDITIONS THE FOLLOWING DEFINITIONS APPLY

Event Estimate means the event order provided with these terms and conditions setting out the details of your event.

Deposit means 50% of the minimum spend specified in the Event Order.

Event Charge means the total of the minimum spend including, food and beverage selections, and any additional amounts payable by you for the event;

Estimated Event Charge means the estimate of the total of the minimum spend including, food and beverage selections, and any other amounts payable by you for the event;

Event Date means the time and date of your event specified in Event Order;

#### 2. DEPOSITS

- 2.1 50% of the minimum spend amount is required within seven (7) days of booking to confirm your event date. The deposit is to be paid with terms and conditions signed and returned before your booking is guaranteed. Tentative bookings without a deposit paid and terms and conditions signed will only be held for a period of seven (7) days. Seed Clare Valley reserves the right to release any tentative bookings after the seven (7) days.
- 2.2 Seven (7) days prior to your event date, 100% of your event minimum spend is required to be paid.
- 2.3 Your deposit is applied towards the event costs (preorganised food, bar tab or package). Deposits are subject to change depending on the time of year and size of the function. These will be communicated to you at your time of booking.

#### **3. PAYMENT**

- 3.1 Full payment of your event is required at least seven (7) days prior to your event date. Services will not be provided without the final payment being received.
- 3.2 Additional consumption charges need to be settled on departure.
- 3.3 Credit card details will be held on file for final settlement purposes. You will be notified regarding any charges processed on your credit card for any breakages, damages, or incidentals.
- 3.4 Minimum spends are subject to change based on time of year. All minimum spends will be determined and communicated at the time of booking and indicated on your contract.

#### **-4. EVENT DETAILS -**

- 4.1 You are required to provide Seed Clare Valley in writing particulars of all food, beverages, entertainment, technical requirements, room setups, starting and finishing times in connection with your event. These details are required at least one (1) month before your event.
- 4.2 Guaranteed numbers final attendance numbers must be notified to Seed Clare Valley seven (7) days prior to your event. Any reduction in attendance numbers within seven (7) days prior to your event will be subject to charge at the full contracted amount.
- 4.3 You must ensure that nothing is nailed, screwed or adhered in any way to any wall, door or another part of the building unless prior permission is granted by Seed Clare Valley.
- 4.4 All decorations must be approved by The Seed Management team and must not use any adhesives, open flames or loose glitter.
- 4.5 The use of smoke machines, special balloon effects and/or pyrotechnics that may affect the Seed Clare Valley smoke detectors are not permitted. Should the Fire Brigade respond to an alarm in the event room, which has been set off by an unauthorised use of smoke machines, special balloon effects and/or pyrotechnics, you will be liable for any charges incurred by Seed Clare Valley.

#### 5. CANCELLATION OR POSTPONEMENT

- 5.1. If for any reason, including those beyond the Organiser's control, except a default on the Licensor's part, the Organiser is unable to proceed with the event on the specified date:
- 5.1.1. The Organiser must immediately notify the Licensor in writing of that fact:
- 5.1.2. Where both parties agree to change the date of the event, the 50% deposit will be retained by the Licensor and used for the new booking.
- 5.2 If cancellation occurs, the Organiser will be charged 5% of the event minimum spend to cover administration fees.
- 5.3 If cancellation occurs within 21 days of the event date, the client will be charged 50% of the event minimum spend.
- 5.4 If cancellation occurs within 7 days of the event date, the client will be charged 100% of the event minimum spend.

#### 6. CONDUCT OF THE FUNCTION

- 6.1 Unless otherwise agreed by Seed Clare Valley, your event must finish at the time specified in the Event Order.
- 6.2 Your event must be conducted in an orderly and lawful manner. Seed Clare Valley reserves the right to end your event if it reasonably believes that your event is not being conducted in an orderly or lawful manner. Seed has no responsibility to you for any costs, damages, or expenses that you may incur in relation to the termination of your event.
- 6.3 Seed Clare Valley may remove or deny entry to anybody being disruptive or acting in a disorderly manner.
- 6.4 Seed Clare Valley practices principles of responsible service of alcohol. Intoxicated persons will not be served alcohol and may be removed from the premises.
- 6.5 You must ensure that you, your guests and invitees at your event do not breach any statutes, by laws, or regulations including Seed Clare Valley's liquor license and fire regulations.

#### 7. CHARGES AND GST

- 7.1 The Event Charge will be based on the rates quoted in the Event Order unless you require any changes to your event in which case Seed Clare Valley will advise you of any charges. The Estimated Event Charge has been provided to you as an indicative figure only.
- 7.2 All rates are given in Australian dollars and are inclusive of Goods and Services Tax as defined in A New Tax System (Goods and Services) Tax Act 1999.
- 7.3 If any additional or increased taxes or levies are introduced after the date of the Event Order, Seed reserves the right to require payment of the relevant additional amount.

#### 8. RESPONSIBILITY & INDEMNITY

- 8.1 Seed Clare Valley is not responsible for the theft, damage or loss of any goods brought onto the premise.
- 8.2 Seed Clare Valley is not responsible for the protection of its guests' property, though we will make every effort to locate lost items.
- 8.3 Function organisers agree to take financial responsibility for any damaged property or excessive cleaning costs incurred as a direct result of the function.

#### 9. AGENCY

- 9.1 Unless otherwise agreed, the party which signs these terms and conditions will be the party responsible for payment of the Event Charge.
- 9.2 If the event is being booked by an agent on behalf of a third party, the third party must also sign these terms and conditions. Alternatively, the agent must provide to Seed Clare Valley written authorisation from the third party which confirms the agent is authorised to sign these terms and conditions.

#### 10. FORCE MAJEURE

10.1. The obligations of a party, other than the obligation to pay money, must be suspended during the time and to the extent that the party is prevented from or delayed in complying with that obligation by Force Majeure.

10.2. Force Majeure means a circumstance beyond the reasonable control of a party which occurs without the fault or negligence of the party affected, and includes inevitable accident, storm, flood, fire, earthquake, explosion, peril of navigation, hostility, war (declared or undeclared), insurrection, executive or administrative order or act of either general or particular application of any government, whether de jure or de facto, or of any official purporting to act under the authority of that government, prohibition or restriction by domestic or foreign laws, regulations or policies, quarantine or customs restrictions, breakdown or damage to or confiscation of property.

10.3. A party affected by Force Majeure must:

10.3.1. as soon as possible after being affected give to the other party full particulars of the Force Majeure and the manner in which its Presentation is prevented or delayed; and

10.3.2. promptly and diligently take appropriate action to enable it to perform the obligations prevented or delayed by
