Terms & Conditions

In these terms and conditions, please be aware that:

"We", "us" and "our" is a reference to Evolve Digital Films.

"You" and "your" is a reference to the bride and groom, jointly and severally.

"wedding video" refers to the digital video recording of your wedding day.

You and we agree as follows:

Our services

We will provide the services, with due care and skill, corresponding to the Package you select in our Booking form, which includes attending each of your nominated premises prior to the wedding ceremony, the wedding service and the reception as set out in the Itinerary to record digital video footage of you, the wedding party, family and friends (our Services) and provide the wedding video to you as selected in the Booking form.

We will do our best to complete the wedding video within eight weeks after your wedding day. The completion period is only an approximate length of time and any longer periods necessary for completion will NOT void this agreement. We will notify you if completion will be longer than this period and try to give you a new approximate completion date.

30 days after the wedding video has been posted or collected, you agree that we may remove your wedding video from our computer unless otherwise agreed by us in writing. If you want any changes to the wedding video, you must request them before this time. We agree to make requested changes at the rate of \$80 per hour, unless the changes requested are of a direct result of an editing error on our part. After this time, you agree that you are satisfied that the wedding video is of acceptable quality.

Additional Costs

Some areas of Melbourne may incur a small travel charge. Other country areas such as Geelong will cost more. Please contact us for a specific quote for your area. If your reception is in a country area, we may require you to provide us with overnight accommodation at your expense.

We will charge you, in addition to the cost of your selected Package, for any additional hours required on your wedding day at the rate of \$150 per hour. If you would like to arrange additional hours in addition to your selected Package, this can be arranged with us prior to the day of your wedding.

Meals on the wedding day

You must provide us with 2 "guest" meals and drinks at the reception (being the same meals as served to your invited guests).

Expenses

You agree to reimburse us for any expenses (including parking, parking fines, admission fees, passes and tickets, etc) that we may incur on your wedding day.

Consents

You agree to obtain consent from each wedding guest for us to digitally video record them at your selected venues on your wedding day and to the use of his or her name, image and voice in any reproductions and wedding videos of your wedding day, including in the wedding video.

You warrant that each wedding guest has freely given his or her consent to:

- (a) being digitally video recorded; and
- (b) the use of his or her name, image and voice in any reproductions and wedding videos of your wedding day, including in the wedding video;
- (c) the use of the wedding video in any advertising or promotion, newsletter, publication, and the 'Testimonials' page of our web site.

Licenses

You are responsible for any copyright licence fees that may be applicable for any music, songs or any other works that is either supplied to us or ordered from us for use with your wedding video and the wedding video and you agree to indemnify us against any third party claims for breach of copyright and for any liability we may incur.

The wedding video

You grant us full control regarding all aspects of the wedding video throughout your wedding day, including when and what to record and we reserve the right to use or omit a particular segment of the wedding video in the wedding video. Of course, we welcome your ideas should you feel the need to input. If you wish to have a review meeting prior to the completion of the editing process, please advise us.

Exclusion of Liability

We are not responsible for loss of any part of the wedding video due to hardware failure or damage. This circumstance is very rare, but can happen, and it is beyond our control. A full refund will be issued to the client should this situation arise.

The inability to complete the agreement by us due to personal accident, illness, death, or other reasons beyond our control entitles you to a return or crediting of monies applicable to that part of the agreement not performed.

To the extent permitted by law, and subject to any rights that cannot be excluded under the Competition And Consumer Act 2010 (Cth), our total liability to you in connection with this agreement whether in contract, tort (including negligence), or otherwise is limited to all monies we received under this agreement.

Copyright

We will own the copyright of the wedding video produced by us as a result of this agreement. We reserve the right to use any of the wedding video for display, advertising and competition purposes.

We retain all copyrights and reproduction rights for the wedding video. You are granted only a license to use the wedding video for private nonprofit uses, unless we give you our permission in writing.
